Executive Reports and Business Items

Director McCollough gave his Director's report. He provided some staff news, updates on the upcoming Mayor's Annual Disability Awareness Expo Co-hosted with DDS Tech Fest on Oct 21st, 2023 and ODR's newletter. Recently, ODR welcomed their new Chief of Staff, Ngoc Trinh, to the agency. Additional, Director McCollough gave updates regarding Olmstead.

The office met with the Mayor's Office of Talent and Appointments (MOTA) about the active commissioners and the vacancies for the Commission.
