DC Department of Transportation has implemented its Red Top Meters: Parking for Persons with Disabilities



Reserved parking spaces for persons with disabilities have a red top meter

All “red top” meters are ADA accessible. Persons with disabilities will be assured exclusive use of reserved “red top” metered parking spaces during regular hours of meter operation.

Red top meters are reserved spaces for persons with disabilities to park with a valid placard. During the hours of meter operations (from 7 am to 10 pm depending on zone) all vehicles that have not paid to park and do not have a valid disability placard will be ticketed and towed from these parking spaces.

Starting March 1, 2012, all parking patrons must display a valid disabled placard or license plate and pay the established meter rates throughout the District of Columbia.

All metered spaces are available to persons with disabilities, however only red top spaces are reserved for their use during the meters hours of operation. Persons with disabilities are allowed to park for ‘twice the time’ allotted at a red top meter with a valid disability placard. For example, if the meter rate on a block face is \$2.00 per hour with a two hour time limit, persons with disabilities will be able to legally park at a red top meter for four hours upon paying the \$8.00 fee. It is illegal to park for more than ‘twice the time’ on any meter in the District, therefore holders of physical disability placards cannot park all day at a meter anywhere in the District of Columbia.

There are two parking rates in the District of Columbia. The Premium Demand Zone rate is \$2.00 per hour and these meters are generally found in the central business district (CBD) as well as segments of commercial corridors such as Connecticut Avenue, NW and Wisconsin Avenue, NW. There are also Normal Demand Zones with a rate of \$.75 per hour and these meters are generally found in mixed as well as some commercial corridors such as Georgia Avenue, NW and H Street, NE.

Mayor Gray Announces Settlement in Longstanding Dixon Lawsuit

February 16, 2012 (WASHINGTON, D.C.) – Mayor Vincent C. Gray today announced a settlement in the 37-year-old Dixon class-action lawsuit and the end of court oversight of the District's public mental health system. U.S. District Court Judge Thomas F. Hogan approved the settlement between the District and Dixon plaintiffs' counsel in a hearing today and dismissed the lawsuit.

"This is an historic day in the District of Columbia, and this settlement affirms the significant progress we have made in building a high-quality, community-based mental health system," said Mayor Gray. "It also is a great victory for District residents, as we have regained control over critical mental-health services and can hold the District government accountable for effective service delivery."

Under the terms of the settlement, the District commits to adding 300 affordable housing units, expanding job-readiness services for adults with mental illness to help them get and keep a job, and increasing treatment services with proven records of good outcomes at home and in the community instead of out-of-home placements for children.

"We are confident that we can meet the obligations of the settlement agreement and make our mental-health system even stronger," said Stephen T. Baron, Director of the Department of Mental Health (DMH).

The Dixon lawsuit was filed in 1974 by patients at Saint Elizabeths Hospital because mental-health treatment in the community was not available to people who did not require institutionalization. At that time, more than 3,600 patients were at Saint Elizabeths. Today, more than 20,000 District residents get mental-health treatment and support from a network of 37 community providers. Less than 300 require residential treatment at Saint Elizabeths.

Wheelchair-Accessible Taxicab Pilot Project in D.C. Gets Good Reviews After First Two Years

TPB Weekly Report (February 14, 2012) Since it began two years ago, the Transportation Planning Board's wheelchair-accessible taxicab pilot program--"rollDC"--has seen an eight-fold increase in the number of trips provided to users of mobility devices living in or visiting the District of Columbia. In a 2011 customer satisfaction survey, 81% of respondents rated their most recent "rollDC" trip either "very good" or "excellent," and nine in ten first-time users said they planned to use the service again in the future.
